**NEW COLLECTION
PICK-UP SCHEDULE
EFFECTIVE APRIL 1**

MONDAY ONLY will be the scheduled pick-up day for waste & recycling collection for the entire City of Richmond Heights.

Recycling collection will move to the first and third Mondays for the streets South of Highland and the second and fourth Mondays for the streets North of Highland.

Please note: You will now be able to co-mingle and mix the recycle items instead of separating them out. Please limit the amount of glass to a liftable bag.

When it is your recycle week, if possible please put the trash on one side of the drive & the recyclables on the other to assist with the collection.

Remember – items must be out for collection by 7:30 a.m.
There will be a change in how residents are billed. They will no longer receive a quarterly bill from (Continued on page 4)

A Message from Mayor Daniel J. Ursu

As most of you are aware, in 2013 the City of Richmond Heights is faced with less revenue from the State of Ohio due to reductions in the Local Government Fund, the elimination of Estate Taxes, the rolling back of the Commercial Activity Tax (C.A.T.) and a new lower Cuyahoga County Property Tax valuation. This will create a hole in our budget of about \$750,000. In fact, most of these funds have been decreasing for years. See page three for details.

Knowing of this impending budget hole, in November of 2011 and again in November of 2012, Council and I placed revenue-raising issues on the ballot that would have addressed this shortfall. As neither passed, and since the City has already gone through reductions in personnel combined with numerous other cutbacks starting in 2009 (see past issues of the "City Edition" online at www.richmondheightsolio.org for details) to balance our budget the past few years, further unfortunate action to help balance our budget in 2013 is needed.

Accordingly, beginning January 1, 2013, City Hall will now be closed on Fridays. The Recreation Department will dramatically reduce its activities and staffing to the minimum level to still comply with Article VI, Section 9 of our Charter to provide some form of recreational activity. The Recreation Department will only be open on Tuesdays and Thursdays. I have accepted the resignation of Recreation Director Teri Drda after 16 years of excellent service and this position will go unfilled to save salary expenses. The pool will be closed this summer to save on operating, utility and maintenance expenses and the numerous seasonal employees such as pool managers and lifeguards who would otherwise be needed to operate the pool. There will continue to be no formal road repair and resurfacing program and most equipment that needs to be replaced will continue to deteriorate due to lack of capital improvement funds.

Lastly, Council and I passed legislation to put on the ballot another attempt at a modest 0.25% increase to the R.I.T.A. tax this May 7. This is needed to maintain our minimal level of services that we now provide.

The City will keep you apprised of other changes that might be necessary as the upcoming year unfolds. For a review of our City's finances, please see Finance Director Paul Ellis' article on page 3.

Let us continue to hope for an economic turnaround in 2013!

PROPOSED INCOME TAX ARTICLE

Financial Director Paul Ellis' Overview of City Financial Position

The City of Richmond Heights continues to experience severe fiscal challenges caused by the loss of revenues from decreased real estate taxes, reductions in revenue from the State of Ohio, and ongoing fixed expenses. These revenue reductions have impacted the quality and level of services delivered to Richmond Heights' residents. The City has taken steps to control and reduce expenditures but has limited options without eliminating vital services or compromising the health and safety of our residents.

Revenues from the real estate taxes fell \$305,000 from 2008 to 2012. Further, the 15% decrease in assessed value from the 2012 reappraisal will result in an additional estimated loss of \$200,000 in receipts to the General Operating fund. The adverse impact from the decline in property values across the county also affects other funds that depend on real estate taxes. These funds include the Fire Service, the Fire Pension, the Police Pension, and the Debt Service funds. Shortfalls in these funds require an increased subsidy from the general fund in order to meet mandatory pension and debt payments.

Intergovernmental payments to the City from the State and County Local Government funds have decreased by \$465,000 from 2008 to 2013. The change in the State formula for distribution to local governments will result in an additional loss of \$136,000 to the City. Further, the elimination by the State of the inheritance tax will result in a loss of revenue of \$145,000 from 2012 to 2013.

Expense reductions alone cannot keep pace with these losses in revenue. As has been noted in past City Editions, in 2009 the City implemented reductions in force in the Police, Building, Recreation, and Fire departments. Further, the hours of administrative staff were reduced. In 2012 the City bid the refuse contract and placed a special assessment on residential properties to cover the cost of pick up and disposal. To further cut expenses in 2013, the City will not open the municipal pool, has implemented reductions in recreation programs, reduced the expenses for street maintenance, and has closed City Hall on Fridays. Capital expenditures to replace deteriorating equipment are minimal.

The City's financial statements have been audited for fiscal years 2009 and 2010 by the Auditor of State. The conversion of fiscal year 2011 cash statements is complete and the work for 2012 is underway. Bank reconciliations are up-to-date. The Auditor of State will be returning in 2013 to complete the audit of fiscal years 2011 and 2012. Due in large part to the above-noted declining revenues, the City's current rating by Moody's Investor Service has been downgraded to Baa1.

Through all of the above-mentioned cuts, the City was able to end 2012 with an unencumbered General Fund balance of \$689,000. The balance is approximately one month of General Fund expense. Although to most readers this might sound like a lot, the balance is close to the minimum standard set by the State in order for the City to avoid the first stage in State financial oversight.

The deficit between revenues and expenses will continue to be a challenge in the coming years for the City of Richmond Heights. We will continue to address the financial issues and work to implement steps to improve financial reporting. We thank you for your continued support and look forward to providing services and information to residents.

The new annual charge to residents will now only be \$101.00 which is a savings of \$17.92 over the expiring annual amount of \$118.92. This is due to a successful and efficient bid process that the City of Richmond Heights implemented to help keep costs down for residents!

POLICE PERSONNEL UPDATE

Although no additional staffing has been added since 10 Police Department employees were laid off in 2009, there have been a few personnel changes within the department. Sergeant Mickey Keri retired in April of 2012 after 25 years of service. In August of 2012, we also lost Sergeant Brian Rinas, who was forced to retire due to an off-duty injury. Sergeant Rinas had been with the department for 18 years. In July, two new officers were hired to replace the two retired sergeants. Officer James McVey and Officer Gregory Patterson joined the force in late July 2012. Both had prior police experience and had completed their basic police training requirements. The officers were assigned to work with Field Training Officers to learn about the city and the operation of the police department.

CUYAHOGA COUNTY AIRPORT INFORMATION

Since 2006, the Cuyahoga County Airport staff has been working diligently to acquire grant funding to improve the airport's infrastructure. Last year, taxiway and apron improvements were completed and now the focus has shifted to runway improvements. The average lifespan of a runway is 20 years and the runway is now 30 years old. There is Federal Aviation Administration funding available for runway improvements but there are conditions. The airport does not currently meet FAA design standards for the Runway Safety Areas, so the safety improvements are necessary for funding the runway repair project.

The Cuyahoga County Airport is about to begin an Environmental Assessment (EA). This is the next step in evaluating the runway safety area improvements identified in the 2010 Airport Master Plan. An EA is required by the National Environmental Policy Act (NEPA) for almost all federal agencies—including the FAA—before a final decision is made to approve projects that could have environmental effects.

Public participation is an essential part of the EA. Electronic and print media tools will be utilized and two open houses and a public hearing will be held over the course of the 18-month project. The first open house was February 27 from 3:30 p.m. - 7:30 p.m. at Cuyahoga County Airport, 26180 Curtiss Wright Parkway, Richmond Heights, Ohio. SANITARY SEWERS UPDATE

Due to inflow and infiltration (I & I) problems with the Sanitary Sewer System, the elimination of which is difficult and costly, Ordinance Number 44-2012 was passed by City Council and signed by the Mayor. Working with the Cuyahoga County Department of Public Works, this enables residents to obtain up to a \$1500 reimbursement for work related to the elimination and/or reduction of basement flooding. The refundable deposit is due when the application is filled out in the Recreation Office. The deposit is returned by mail to the resident if the staff finds no damages and all rules were followed by the renter. The fee is due one month before the event. COMMUNITY TREE PLANTING EVENT & ARBOR DAY CELEBRATION ON SATURDAY, APRIL 27

Come one, come all to City Hall! On Saturday, April 27, from 9:00 a.m. until 1:00 p.m., you, your family and neighbors can help Reforest Richmond Heights. There will be an Arbor Day Celebration after the tree planting is completed.

Volunteers are needed for planting, mulching and donut distribution. If you'd like to be a team leader, and learn the proper way to plant and mulch trees so that you can teach others, training will begin at 8:00 a.m. Planting volunteers will gather in front of City Hall at 9:00 a.m. To volunteer, or for more information, please contact Cathi Lehn at (216) 241-2414 extension 307, or e-mail lehnc@crcpo.org.

Cuyahoga ReLeaf, a program that keeps woods working for watersheds, will hold a community tree planting beside the creek along Highland Road east of Richmond Road. ReLeaf partners and volunteers will plant more than a hundred trees, some large, some small, along 770 feet of Claribel Creek, which leads to Euclid Creek.

With funding from the U.S. Forest Service and ODNR Division of Forestry, and *at no cost to the community*, the project provides the trees, tools, equipment and training to communities throughout the area in an effort to reduce stormwater runoff and restore riparian areas to improve stream health. Trees and healthy urban forests are the most important pieces of a community's ecosystem, absorbing hundreds of gallons of stormwater, providing shade to aquatic life and habitat for birds, cooling the soil and cleaning the air, and beautifying our City.

NORTHEAST OHIO REGIONAL SEWER DISTRICT STORMWATER MANAGEMENT FEE

The Northeast Ohio Regional Sewer District Stormwater Management Program will begin collecting fees on Richmond Heights properties that are located in the Stormwater District only beginning January 1, 2013. For Richmond Heights, the Stormwater District is the same as the Wastewater Treatment District. The stormwater fees are based on the amount of impervious surface on your property. The basics of the stormwater fee are:

1. Residential property is grouped into one of three tiers and charged one of three flat fees per quarter. Residential property in Richmond Heights is either in Tier 2 or Tier 3. The quarterly fee for Tier 2 property is \$15.15 and the Tier 3 fee is \$27.27.
2. Northeast Ohio Regional Sewer District customers qualifying for the Homestead Fee and/or the Sewer District's Cost Savings Programs will also qualify for these savings under the Regional Stormwater Management Program.
3. In order to determine what fee will be charged on your property, take the following steps.
 - a. On the web go to www.neorsd.org
 - b. Click "Stormwater and Watersheds" on the left side of the home page
 - c. Click "Stormwater management program" on the left side of the page
 - d. Click "Find your fee" in the blue box on the right side of the page
 - e. Enter your address in the search box on the map and then click the magnifying glass on the left side of the search box
 - f. Click your property outlined in red

Many residents of Richmond Heights are part of the Euclid Wastewater Treatment District and will not incur the above-mentioned fee. If you are unsure of whether the fee applies to you, follow the steps in #3 above.

CPR COURSE OFFERED BY RICHMOND HEIGHTS FIRE DEPARTMENT

Beginning in March, Richmond Heights Fire Department in partnership with UH Richmond Medical Center will offer bi-monthly CPR courses to residents of Richmond Heights. The Heartsaver® CPR AED Course is a classroom, video-based, instructor-led course that teaches adult CPR and AED use, as well as how to relieve choking on an adult. The course will be held at the Richmond Heights fire station on **March 18 from 6:30 p.m. to 9:30 p.m.** Call City Hall at (216) 486-2474, if interested. Class size is limited to 12 students per class. These classes are **FREE** to residents of Richmond Heights. This course is for the general public; it is not the Healthcare Provider Course. Participants must be at least 16 years old to attend.

EUCLID CREEK WATERSHED IMPLEMENTATION

The City Of Richmond Heights was awarded \$187,500 through Ohio EPA's SWIF program to green an historic, City-owned property called Greenwood Farm located on the East Branch of Euclid Creek near Chardon Road on Richmond Road. The project includes construction of new driveways and parking areas for volunteers and visitors. Instead of conventional paving systems, porous pavement will be installed to allow water to infiltrate into the ground versus sheet flowing and picking up pollutants that will enter nearby Euclid Creek. Bioretention areas will be installed to receive storm water runoff from the new driveway and parking areas, and from roof runoff from the main farmhouse and barn.

SCHOLARSHIPS FOR RICHMOND HTS. GRADUATING SENIORS

Keep in mind that the application process will be confidential and the material will be passed along from the guidance office to the Richmond Heights Garden Club and Richmond Heights Kiwanis Club Scholarship Committees only.
