A RESOLUTION TO AUTHORIZE THE MAYOR TO ENTER INTO AN AGREEMENT WITH TIME WARNER ENTERTAINMENT COMPANY, L.P. FOR CABLE BUSINESS CLASS SERVICE.

WHEREAS, pursuant to Ohio Revised Code § 1332.21, et seq., the City no longer has free cable service pursuant to a franchise with a cable operator in the City and, therefore, there is a need for the City to contract with a cable operator for cable service going forward; and

WHEREAS, the Director of Public Service has recommended a thirty-six (36) month contract with Time Warner Entertainment Company, L.P. to provide cable service to the Service Department building at 26260 Chardonview Drive;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a contract with Time Warner Entertainment Company, L.P. for cable service for a term of thirty-six (36) months at a rate of Sixty-Nine and 95/100 Dollars (\$69.95) per month, as set forth in the Agreement attached hereto and incorporated herein as Exhibit A.

Section 2: The Director of Finance is authorized to appropriate to a proper account the funds necessary for the contract authorized in Section 1 of this Resolution.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
