

RESOLUTION NO.: 98 -2015

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH MJH CONTRACTORS FOR CERTAIN ROAD WORK TO BE COMPLETED AT THE INTERSECTION OF BRUSH AND CHARDON ROADS AND DECLARING AN EMERGENCY.

WHEREAS, the Dominion East Ohio Gas Company (the "Gas Company") is engaged in making certain repairs and/or improvements to its facilities located within the public right of way at the intersection of Brush and Chardon Roads in the City; and

WHEREAS, as a result of those repairs and/or improvements, certain repaving of roadways is required; and

WHEREAS, the City, through its Engineer, and at the recommendation of Council's Service & Recreation Committee, has determined that additional repaving work is necessary in the area immediately adjacent thereto and unrelated to the Gas Company project; and

WHEREAS, the Gas Company's contractor, MJH Contractors, is able to perform the unrelated paving repair work at a significant cost savings to the City since it is already performing similar work in the subject area and it has agreed to perform the work immediately in an amount not to exceed four thousand one hundred dollars (\$4,100.00).

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a contract with MJH Contractors for certain roadway repairs and resurfacing as specified by the City Engineer in the area of Brush and Chardon Roads in an amount not to exceed four thousand one hundred dollars (\$4,100.00).

Section 2: The Director of Finance is authorized to appropriate to a proper account/fund the amount necessary to cover the cost of the work that is the subject of Section 1 of this Resolution.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and general welfare of the City, and for the City to immediately enter into an agreement with MJH Contractors for certain roadway repairs and resurfacing in the area of Brush and Chardon Roads for the safety of the motoring public; wherefore, this Resolution shall take effect and be in force effective immediately upon its passage by Council and signature of the Mayor.
