

RESOLUTION NO. 30 -2016  
INTRODUCED BY: Lentine

A RESOLUTION AUTHORIZING THE MAYOR TO PURCHASE A HYDRAULIC TOOL POWER UNIT FOR THE DIVISION OF FIRE; AND DECLARING AN EMERGENCY.

WHEREAS, the Division of Fire has requested and the Council's Safety Committee has recommended the replacement of the power unit for a hydraulic extrication tool at a cost not to exceed Nine Thousand Dollars (\$9,000.00).

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with Sutphen Corporation, of Amlin, Ohio for the purchase of one (1) Holmatro SR-20 Power Unit-CORE and related equipment for the Division of Fire at a cost not to exceed \$9,000.

Section 2: The Director of Finance is authorized to appropriate to a proper account the amount deemed necessary to cover the cost for the purchase of the equipment as set forth in Section 1 above.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution is declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and general welfare of the citizens of the City of Richmond Heights, and for the further reason that it is necessary to immediately place the order for the equipment due to the lengthy production period; therefore, provided this Resolution receives the affirmative vote of five members of Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
