A RESOLUTION AUTHORIZING THE MAYOR AND DIRECTOR OF FINANCE TO PAY AN ADDITIONAL \$7,000 FOR AN EMERGENCY AMBULANCE VEHICLE IN LIEU OF A TRADE-IN OF AN EXISTING CITY AMBULANCE AND AMENDING RESOLUTION NO. 17-2017 OF THIS COUNCIL.

WHEREAS, pursuant to Resolution No. 17-2017, passed by this Council on March 28, 2017, Council authorized the purchase of a new emergency ambulance through the State of Ohio Department of Administrative Services Cooperative Purchasing Program for the amount of \$198,675 and with a trade-in allowance of \$7,000 from the vendor, Pfund Superior Sales Co., Inc., on an existing ambulance of the City that will be going out of service;

WHEREAS, prior to delivery of the new ambulance and the signing over of the title to the City's current ambulance that is going out of service, the City's Director of Public Service and Properties has recommended to Council that the City retain the current ambulance that was to be traded in for use by the City Service Department;

WHEREAS, the vendor has agreed to not take the trade-in of the City's current ambulance but conditioned on the \$7,000 trade-in allowance to now be included in the purchase price of the new ambulance and this Council is in agreement therewith;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor and Director of Finance are authorized to pay an additional \$7,000.00 for one new ambulance, that being a 2017 Ford F-550 4X4 Life Line "Custom Superliner" Type I ambulance, from Pfund Superior Sales Co., Inc. at the cost of \$205,675.00, which continues to be under State Schedule Contract Vendor No. 800217, as part of the State of Ohio's Cooperative Purchasing Program.

Section 2: The Director of Finance is authorized and directed to appropriate to a proper account the additional \$7,000.00 for the purchase set forth in Section 1 above in the total amount not to exceed \$205,675.00.



Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of
