

RESOLUTION NO.: 98-2017

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH TAC COMPUTER FOR THE PURCHASE OF A NETWORK SERVER, SWITCHES AND A VIDEO/PHOTO STORAGE SERVER FOR THE DIVISION OF POLICE.

WHEREAS, the amount of digital photos and videos kept by the Division of Police has increased over time and the Division's main server does not have space for these digital files; therefore, the Police Chief has recommended that the City purchase a Synology DS1815+ NAS server with WD Red Pro 4 TB 7200 RPM Drive to store the Division's digital photos and videos; and

WHEREAS, the Police Chief has recommended that the Division's current Dell server be replaced with an MH Network Server; and

WHEREAS, the Division of Police computer system is operating with one switch and the Police Chief has recommended that the City purchase two switches that are Gigabit capable with power over Ethernet to replace the existing, outdated switch; and

WHEREAS, since this Resolution No. 98-2017 was introduced by Council, the Police Chief has received a revised quote from TAC Computer dated October 17, 2017, for one HP ML350 Gen 9 Network Server and two HP ProCurve 48 port switches, in an amount not to exceed \$11,922.00, and one Synology DS1517+backup server with WD Red Pro 4 TB 7200 RPM Drive, in an amount not to exceed \$3,785.00; and

WHEREAS, Council's Safety Committee and Finance Committee have reviewed the need for this proposed purchase and recommend the same to Council as reflected in the revised quote dated October 17, 2017, which changed the cost and models for some of the parts and components from an earlier quote.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with TAC Computer for the purchase of one HP ML350 Gen 9 Network Server HP Network and, two HP ProCurve 48 port switches in an amount not to exceed \$11,922.00, and one Synology DS1517+backup server with WD Red Pro 4 TB 7200 RPM Drive, in an amount not to exceed \$3,785.00, for a total cost not to exceed \$15,707.00.


Section 2: If necessary, the Director of Finance is authorized and directed to appropriate to a proper account a sum sufficient to cover the cost of said agreement referred to in Section 1 above.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council,

and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
