

RESOLUTION NO.: 65-2019

A RESOLUTION ACCEPTING A BID FOR THE VARIOUS SECTIONS OF THE BID SPECIFICATIONS FOR REPAIRS AND RESURFACING OF VARIOUS CITY STREETS FOR THE 2019 ROAD PROGRAM AND AUTHORIZING A CONTRACT THEREFOR.

WHEREAS, pursuant to legal notice therefor, duly published according to law, three sealed bids were received at the office of the Clerk of Council of the City of Richmond Heights for labor and materials for repairs and resurfacing of various City streets for the City's 2019 Road Program in accordance with specifications prepared by the City Engineer and on file in the office of the Clerk of Council;

WHEREAS, pursuant thereto, the lowest and best bid received for said labor and materials for the various Sections of the Road Program bid specifications was:

SECTIONS I, IA, II, IIA, III, and IIIA: Specialized Construction, Inc. at \$424,830.00;

WHEREAS, the Road Program contract specifications are bid on both a labor and material unit basis for the quantity of work performed and the current appropriation by this Council for this contract at this time is \$400,000.00;

WHEREAS, the City Engineer has reviewed the bid of Specialized Construction, Inc. and, based on current circumstances, recommends that the unit prices bid by that company be accepted by this Council and the extent of construction work be limited in any contract therefor to the extent of the work set forth in the bid specifications and within the current appropriation of Council of \$400,000.00;


NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The unit prices for labor and materials bid by Specialized Construction, Inc. are accepted by this Council but a contract with that company is hereby authorized at this time for total construction costs in an amount not to exceed \$400,000.00 for Sections I, IA, II, IIA, III and IIIA of the City's bid specifications for all labor and materials for resurfacing and repairs of various City streets for the 2019 City Road Program, and the Mayor and Director of Finance are authorized to execute the contract.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


