

RESOLUTION NO.: 17 -2021

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT THROUGH THE OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES' COOPERATIVE PURCHASING PROGRAM FOR THE PURCHASE OF BUILD-OUT PACKAGES FOR THREE FREIGHTLINER TRUCK CABS AND CHASSIS FOR USE BY THE DEPARTMENT OF PUBLIC SERVICE.

WHEREAS, the City applied for and received grant funds from the Ohio Environmental Protection Agency, which administers the Volkswagen Mitigation Trust Fund for the purchase by local governments of diesel-powered vehicles and equipment on a reimbursement and matching funds basis;

WHEREAS, the City proposed to purchase two (2) Freightliner brand truck cabs and chassis with build-out packages, including dump bed, salt spreader and snow plow, and one (1) Freightliner brand truck cab and chassis with build-out package of dump bed only, for a total cost of \$383,040, and received a grant in the amount of \$211,474, with the remainder of the project cost to be provided by the City as matching funds;

WHEREAS, this Council has previously authorized cooperative purchasing through the Ohio Department of Administrative Services' Cooperative Purchasing Program which is also authorized by the City Charter;

WHEREAS, the City received quotes dated February 13, 2021 and February 14, 2021, from Concord Road Equipment, Mfg., an approved vendor the Ohio Department of Administrative Services' Cooperative Purchasing Program, to supply two (2) dump body snow & ice control equipment packages to be installed on customer-supplied single axle class 8 cabs and chassis for the amount of \$131,630 and one (1) dump body and hoist package to be installed on customer-supplied single axle class 8 cab and chassis for the amount of \$13,520;

WHEREAS, this Council desires to authorize the procurement of two (2) dump body snow & ice control equipment packages and one (1) dump body and hoist package to be installed on customer-supplied Freightliner truck cabs and chassis, the purchase of which can be made through a State-approved vendor, Concord Road Equipment, Mfg., through the Ohio Department of Administrative Services Cooperative Purchasing Program under Index No. STS515, Schedule No. 800860, in an amount not to exceed \$145,150.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Concord Road Equipment, Mfg. for the purchase of two (2) dump body snow & ice control equipment packages and one (1) dump body and hoist package to be installed on customer-supplied Freightliner truck cabs and chassis, as more fully set forth in the preamble of this Resolution, which, together with the purchase of three (3) Freightliner brand truck cabs and chassis, will not exceed \$383,040 and will be offset by the \$211,474 grant to the City from the Ohio EPA.

Section 2: The Finance Director is authorized and directed to appropriate to a proper account a sum sufficient to cover the cost of said purchase agreement referred to in Section 1 above.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
