

RESOLUTION NO.: 43 -2021

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH TIM LALLY CHEVROLET FOR A SPECIAL SERVICE VEHICLE AT A COST AT OR BELOW THE OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES COOPERATIVE PURCHASING PROGRAM BID PRICING FOR USE BY THE DIVISION OF FIRE.

WHEREAS, pursuant to the City Charter, Council has heretofore authorized cooperative purchasing through the State of Ohio Department of Administrative Services' Cooperative Purchase Program and purchases from vendors offering pricing at or below State Purchasing Program bid pricing;

WHEREAS, the Chief of Fire has advised this Council that the Division of Fire is in need of one (1) chase utility vehicle, and is recommending a 2021 model year Chevrolet Tahoe 4x4 Special Service Vehicle ("SSV");

WHEREAS, the Chief of Fire has received a proposal from Tim Lally Chevrolet, Inc., 24999 Miles Road, Warrensville Heights, Ohio 44128 for one (1) 2021 model year Chevrolet Tahoe 4x4 SSV for the amount of \$48,100.00, which is at or below the State Cooperative Purchasing Program bid price for a 2021 Chevrolet Tahoe 4x4 SSV;

WHEREAS, Council's Safety and Finance Committees have reviewed the need for this proposed purchase and recommend the same to Council;


NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement for the purchase of one (1) 2021 model year Chevrolet Tahoe, 4x4 SSV, from Tim Lally Chevrolet, Inc. at a cost not to exceed \$48,100.00, as set forth in the recitals to this Resolution.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


