**A RESOLUTION AUTHORIZING THE DISPOSAL OF
EQUIPMENT THAT IS UNNEEDED, OBSOLETE AND UNFIT FOR
CITY PURPOSES.**

Whereas, the Chief of Police and the Mayor/Director of Public Safety have recommended the disposal and discarding of City equipment once used by the Division of Police and listed in Exhibit A, which is attached hereto and incorporated by reference herein, all of which is unneeded, obsolete and unfit for municipal purposes;

Whereas, Section 721.15 of the Ohio Revised Code provides for the discarding of such equipment by authorization of this City Council;

NOW, THEREFORE, BE RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Chief of Police is authorized to dispose of and discard the equipment set forth in Exhibit A to this Resolution as being unneeded, obsolete and unfit for City purposes.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


