

RESOLUTION NO.: 15-2022

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH CHAGRIN VALLEY DISPATCH FOR THE PROVISION OF CAPITAL IMPROVEMENTS AND THEIR ANNUAL SUPPORT FOR THE CITY'S COMMUNICATIONS NETWORK UPGRADE PROJECT.

WHEREAS, the Mayor has advised this Council that the City's computer and communications network is outdated and is in need of immediate capital improvements, including a new telephone system, network upgrades, firewall replacement, new servers, new desktop computers and a fiber link between the Division of Police and City Hall, along with the necessary annual support thereof for the new technology (the "Network Upgrade Project"), for the protection of the public health, safety and welfare, all of which can be provided by a regional council of governments, Chagrin Valley Dispatch, which also serves as the City's emergency dispatch center;

WHEREAS, Chagrin Valley Dispatch has proposed to provide the Network Upgrade Project, as set forth in its proposal dated February 7, 2022, for a total price not to exceed \$63,882.00, and the Mayor and her staff are recommending that the City enter into an agreement for the provision of the Network Upgrade Project by Chagrin Valley Dispatch;


WHEREAS, the components of the Network Upgrade Project will be purchased by Chagrin Valley Dispatch from vendors participating in Ohio state cooperative purchasing programs, and/or from vendors that will provide the components at or below the state cooperative purchasing program contract price, and the total cost of the Network Upgrade Project shall not exceed Sixty-Three Thousand Eight Hundred Eighty-Two Dollars (\$63,882.00).

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with Chagrin Valley Dispatch for the Network Upgrade Project at a total cost not to exceed Sixty-Three Thousand Eight Hundred Eighty-Two Dollars (\$63,882.00), which agreement shall be as approved for legal form and correctness by the Director of Law.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
