

RESOLUTION NO.: 74 -2022

INTRODUCED BY: Mayor Thomas and All of Council

A RESOLUTION REAPPOINTING CITY OF RICHMOND HEIGHTS APPOINTEE MEMBERS FRED CASH AND BRIAN GLEISSER TO THE BOARD OF TRUSTEES OF THE BELLE OAKS NEW COMMUNITY AUTHORITY; AND DECLARING AN EMERGENCY.

WHEREAS, on June 9, 2020, the Council of the City of Richmond Heights (organizational board of commissioners per Ohio Revised Code §349.01), by the passage of Resolution No. 54-2020, established the Belle Oaks New Community Authority as a body politic and corporate for the purposes described in that Resolution;

WHEREAS, this Council determined, by the passage of Resolution No. 54-2020, that the Board of Trustees shall be comprised of seven (7) members selected and appointed as provided in the Petition for the New Community Authority;

WHEREAS, pursuant to the authority to establish a new community authority set forth in Chapter 349 of the Ohio Revised Code, and Resolution No. 54-2020, this Council appointed, by the passage of Resolution No. 58-2020, citizen member Fred Cash and Richmond Heights municipal government member Brian Gleisser to the Board of Trustees of the New Community Authority, each to a two-year term expiring at 11:59 p.m. on June 15, 2022;

WHEREAS, pursuant to this Council's authority set forth in Chapter 349 of the Ohio Revised Code, this Council desires to reappoint Fred Cash and Brian Gleisser to the Board of Trustees of the Belle Oaks New Community Authority, each to an additional two-year term beginning on June 16, 2022 and expiring at 11:59 p.m. on June 15, 2024.

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:


Section 1: Appointees Fred Cash and Brian Gleisser are reappointed as appointees of the Council of the City of Richmond Heights to the Board of Trustees of the Belle Oaks New Community Authority, each for a two-year term beginning June 16, 2022 and expiring at 11:59 p.m. on June 15, 2024;

Section 2: All formal actions of this Council and any of its committees concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council were had in compliance with the law, including R.C. Section 121.22.

Section 3: This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that the foregoing reappointments must be made before the expiration of the appointees' current terms to ensure continuous representation by these Council appointees to the Belle Oaks New Community Authority; wherefore, provided this

Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.


