

RESOLUTION NO.: 92 -2022

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH MUNSON TOWNSHIP FOR THE PURCHASE OF A 2012 FORD F-450 TYPE III AMBULANCE FOR THE DIVISION OF FIRE UTILIZING AMERICAN RESCUE PLAN ACT FUNDS.

WHEREAS, the Chief of Fire has advised this Council that a reserve ambulance would maintain the expedient availability of an advanced life support unit in the City of Richmond Heights;

WHEREAS, the Division of Fire has requested and the Council's Safety Committee has recommended the purchase of a 2012 Ford F-450 Type III ambulance at a cost of Thirty-Five Thousand Dollars (\$35,000.00) utilizing funds from the Local Fiscal Recovery Fund created to deposit American Rescue Plan Act (ARPA) funds;

WHEREAS, pursuant to Ohio Revised Code Section 735.052, the City of Richmond Heights is authorized to enter into contract without advertising and competitive bidding for the purchase of used equipment or supplies at an auction open to the public, or at a sale at which such used equipment or supplies are to be sold upon submission of written bids to the vendor thereof where the vendor has invited the public to submit written bids or when more than one bid is submitted;

WHEREAS, by a unanimous motion passed on June 28, 2022, this Council authorized the Mayor to submit a sealed bid for the purchase of the 2012 Ford F-450 Type III ambulance from Munson Township pursuant to the public notice of Munson Township to accept sealed bids by July 8, 2022 for the purchase of the used ambulance;

WHEREAS, the Division of Fire participated in the sealed bid process for the 2012 Ford F-450 Type III ambulance owned by Munson Township and the bid was accepted;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with Munson Township for the purchase of a 2012 Ford F-450 Type III ambulance for the Division of Fire at a total cost of \$35,000.00 utilizing funds from the Local Fiscal Recovery Fund.

Section 2: The Director of Finance is authorized to expend funds from the Local Fiscal Recovery Fund in the amount deemed necessary to cover the cost for the purchase of the equipment as set forth in Section 1 above.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


