AN ORDINANCE APPROVING THE CODIFICATION, EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF RICHMOND HEIGHTS, OHIO, AND APPROVING THE UPDATING OF VARIOUS SECTIONS OF THE TRAFFIC AND GENERAL OFFENSES CODES TO COMPLY WITH STATE LAW.

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Richmond Heights, Ohio; and

WHEREAS, numerous sections in the current Traffic and General Offenses Codes need to be revised to reflect the current law in Ohio.

NOW, THEREFORE, Be It Ordained by the Council of the City of Richmond Heights, State of Ohio, that:

SECTION 1. The codification, editing, arrangement and numbering or renumbering of the following ordinances and parts of ordinances are hereby approved as parts of the various component codes of the Codified Ordinances of Richmond Heights, Ohio, so as to conform to the classification and numbering system of the Codified Ordinances, to-wit:

SECTION 5. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
