A RESOLUTION AUTHORIZING THE SALE OF UNNEEDED ITEMS OF
SPECIFIC PERSONAL PROPERTY OF THE CITY OF RICHMOND
HEIGHTS PUBLIC SERVICE DEPARTMENT AND DIVISION OF POLICE
THROUGH AN INTERNET AUCTION BY GOVDEAL.COM, INC.

WHEREAS, Ohio Revised Code §721.15 authorizes this Council to adopt a resolution to authorize the sale by internet auction of personal property owned by the City, including personal property items referenced in §721.15 which are no longer needed for public use or obsolete or unfit for the use for which they were acquired and Council adopted Resolution No. 6-2020 to authorized internet auction sales during 2020, as required by R.C. 721.15;

WHEREAS, the Department of Public Service and the Division of Police have requested to sell personal property items that are unneeded, obsolete and/or unfit for the use for which they were acquired through an internet auction to be administered by GovDeals.com, Inc.;

WHEREAS, at this time, this Council also wishes to authorize the sale of the items of personal property of the City that are listed in Exhibit A to this Resolution which this Council finds are not needed for public use, obsolete and/or unfit for the use for which they were acquired.


NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The items of personal property listed in Exhibit A to this Resolution are determined not to be needed for public use, and/or are obsolete or unfit for the use for which they were acquired and may be sold through an internet auction procedure by GovDeals.com, Inc.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Resolution shall take effect from and after the earliest period allowed by law.
