

RESOLUTION NO. 94-2020
INTRODUCED BY: Lentine

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH STRYKER MEDICAL, INC. FOR THE INSPECTION, SUPPORT AND SERVICING OF CERTAIN DIVISION OF FIRE LIFE-SAVING EQUIPMENT.

WHEREAS, Council's Safety Committee has recommended entering into a service agreement with Stryker Medical, Inc. for the inspection, support and servicing of two (2) Physio-Control LIFEPAK 15 cardiac monitors/defibrillators assigned to the Division of Fire at a cost not to exceed Twelve Thousand Two Hundred Forty and 00/100 Dollars (\$12,240.00);

WHEREAS, Stryker Medical, Inc. has consistently provided the City's Division of Fire with on-site preventative maintenance services, software updates, overall excellent customer service in response to service calls, with prompt replacement of parts and equipment, all of which are included in such service agreement;

WHEREAS, Stryker Medical, Inc. is the unique and sole source provider of such services and equipment, and does not authorize or train third parties to service its products, and therefore, it is necessary to enter into a technical services support agreement with said company for a four (4)-year period to commence on October 6, 2020;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:


Section 1: The Mayor is authorized to enter into a Technical Support Agreement with Stryker Medical, Inc. in an amount not to exceed Twelve Thousand Two Hundred Forty and 00/100 Dollars (\$12,240.00) for a period of four (4) years, commencing on October 6, 2020 through October 5, 2024, as is more fully set forth in "Exhibit A", attached hereto and incorporated herein by reference.

Section 2: To the extent that it is necessary, the Director of Finance is authorized to appropriate to a proper account/fund the amount necessary to cover the cost of the service agreement that is the subject of Section 1 of this Resolution.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


