

RESOLUTION NO.: 137 -2022
INTRODUCED BY: ALL OF COUNCIL

A RESOLUTION DOCUMENTING THE MOTION OF THE CITY COUNCIL ON OCTOBER 11, 2022, TO ACCEPT THE BID OF SPECIALIZED CONSTRUCTION, INC. FOR SECTIONS I AND I-A OF THE BID SPECIFICATIONS FOR THE 2022 REPAIR AND RESURFACING OF VARIOUS CITY STREETS AND AUTHORIZING A CONTRACT THEREFOR.

WHEREAS, at this Council's October 11, 2022 regular meeting, the Council passed a motion by a vote of six to zero to accept the bid of Specialized Construction, Inc. for Sections I and I-A of the bid specification for the 2022 Repair and Resurfacing of various City streets and to authorize a contract with Specialized Construction therefor, which bid solicitation was duly published according to law, and which resulted in two (2) sealed bids being received at the office of the Clerk of Council of the City of Richmond Heights for labor and materials;

WHEREAS, pursuant thereto, the lowest and best bid received for said labor and materials for Sections I and I-A of the 2022 Road Repair and Resurfacing Program bid specifications was submitted by Specialized Construction, Inc. in the total amount of \$560,777;

WHEREAS, this Council wishes to further document and confirm its verbal motion to accept the bid of Specialized Construction, Inc. and to authorize a contract therefor for clarity of the City's official record thereof.

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: By this Resolution, this Council documents its motion passed at its October 11, 2022 regular meeting to accept the bid of Specialized Construction, Inc. for Sections I and I-A of the bid specifications for the 2022 Repair and Resurfacing of Various City Streets and to authorize a contract therefor with Specialized Construction, Inc. in an amount not to exceed \$560,777.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
