A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH BIOMETRIC INFORMATION MANAGEMENT FOR THE PURCHASE OF A NATIONAL WEBCHECK SYSTEM FOR CITY-WIDE USE.

WHEREAS, the Chief of Police has received a quotation, dated October 20, 2022, from Biometric Information Management, 6059 Frantz Road, Suite 102, Dublin, Ohio 43017, to provide a complete National WebCheck system, including hardware and software, for the price of \$6,800.00, as set forth in the quotation attached hereto as Exhibit A;

WHEREAS, the Chief of Police and this Council's Safety Committee have reviewed the need for this purchase and recommend to the Council that the Mayor be authorized to enter into a contract with Biometric Information Management for the purchase of a complete National WebCheck system for City-wide use for an amount not to exceed \$6,800.00.

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:



Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


