A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A
PURCHASE AGREEMENT WITH TREETOP PRODUCTS INC. FOR THE
PURCHASE OF OUTDOOR FURNITURE, RECYCLE CONTAINERS, AND
TRASH RECEPTACLES FOR THE CITY'S PARKS

WHEREAS, pursuant to the City Charter, Council has heretofore authorized cooperative purchasing through the State of Ohio Department of Administrative Services Cooperative Purchase Program and the cooperative purchasing programs of other political subdivisions;

WHEREAS, pursuant to state law, political subdivisions may purchase from other vendors upon equivalent terms, conditions and specifications, but at a lower price that it can through the contracts of a cooperative purchasing program;

WHEREAS, the City has received a quote from TreeTop Products Inc. for the purchase of outdoor furniture, recycling containers and trash receptacles for pricing in an amount lower than the pricing under the Costars cooperative purchasing program for the Commonwealth of Pennsylvania, the Kentucky Purchasing Cooperative Purchasing Program, and Ohio's Cooperative Purchasing Program, as set forth in the quote attached hereto as Exhibit A;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with TreeTop Inc. for the purchase of outdoor furniture, recycling containers and trash receptacles, as set forth in the quote attached as Exhibit A, at a cost not to exceed \$127,106.21 to come from the ARPA Fund.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Resolution shall take effect and be in force form and after the earliest period allowed by law.
