A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH CONCORD ROAD EQUIPMENT MFG. THROUGH THE OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES COOPERATIVE PURCHASING PROGRAM FOR LEAF WOOD CHIP COLLECTION EQUIPMENT FOR THE DEPARTMENT OF PUBLIC SERVICE AND UTILIZING AMERICAN RESCUE PLAN ACT FUNDS.

WHEREAS, Council has authorized cooperative purchasing through the competitive bids obtained by the State of Ohio Department of Administrative Services Cooperative Purchasing Program; and

WHEREAS, the Service Director has requested the purchase of three (3) 10-foot leaf collection boxes and one (1) 10-foot wood chip collection box, dump-body insert mounts, the purchase of which can be made through the State of Ohio's Cooperative Purchasing Program from Concord Road Equipment Mfg. under State Term Schedule Contract No. 800925 for a price not to exceed \$24,992.49 for the leaf collection boxes and \$7,300.28 for the wood chip collection box utilizing local recovery funds distributed under the American Rescue Plan Act (ARPA);

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement for three (3) leaf collection boxes and one (1) wood chip collection box, as described above, from Concord Road Equipment Mfg. at a cost not to exceed the total amount of \$32,292.77 under State Term Schedule Contract No. 800925 utilizing local recovery funds under ARPA.


Section 2: The Director of Finance is authorized to expend funds from the ARPA fund in the amount deemed necessary to cover the cost for the purchase of the equipment as set forth in Section 1 above.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


