

RESOLUTION NO.: 137 -2023

**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH GLOBAL LED SOLUTIONS FOR LED LIGHTING FOR CITY HALL AND THE POLICE STATION.**

WHEREAS, the City has received three (3) proposals, dated July 25, 2023, from Global LED Solutions for LED lighting for City Hall and the Police Station, in a total amount of \$19,760.19;

WHEREAS, the Director of Public Service has recommended to this Council and this Council desires to enter into a contract with Global LED Solutions for LED lighting for City Hall and the Police Station on the basis of its proposals dated July 25, 2023;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a contract with Global LED Solutions for LED lighting for City Hall and the Police Station in an amount not to exceed Nineteen Thousand Seven Hundred Sixty Dollars and Nineteen Cents (\$19,760.19), as set forth in the three (3) invoice proposals attached hereto as Exhibit "A" and incorporated herein.

Section 2: For the cost of the contract authorized in Section 1, the Director of Finance is authorized to appropriate funds in the amount of \$11,220.00 from NOPEC grant funds, and to appropriate funds in an amount necessary to cover the remaining cost of the contract from local fiscal recovery ARPA funds.


