

RESOLUTION NO. 162 -2023  
INTRODUCED BY: Lentine

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH STRYKER MEDICAL FOR THE PURCHASE OF ONE LUCAS 3 CHEST COMPRESSION SYSTEM AND ONE POWERED "XPEDITION" STAIR CHAIR FOR THE DIVISION OF FIRE AND UTILIZING OHIO BUREAU OF WORKERS' COMPENSATION SAFETY INTERVENTION GRANT FUNDS.

WHEREAS, the Division of Fire has requested, and the Council's Safety Committee has recommended the purchase of one (1) LUCAS 3 Chest Compression System and One (1) powered "XPEDITION" Stair Chair from Stryker Medical at a cost not to exceed Thirty-Six Thousand Three Hundred Ninety-One Dollars and Forty-Five Cents (\$36,391.45);

WHEREAS, the City has received an Ohio Bureau of Workers' Compensation "Safety Intervention Grant" in the total amount of \$27,293.59 for this purchase, which includes a requirement of twenty-five percent (25%) matching funds by the City in the amount of \$9,097.86;

WHEREAS, Stryker Medical Division of Portage, Michigan, is the sole source of the aforesaid patient care systems utilized in the City's ambulances permitting the interchangeable use of either ambulance for this type of system;

WHEREAS, the required equipment is available from Stryker Medical and the City will be required to pay the entire amount for the items and will be reimbursed in the amount of \$27,293.59 from the grant funds.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:


Section 1: The Mayor is authorized to enter into an agreement with Stryker Medical for the purchase of one (1) LUCAS 3 Chest Compression System and One (1) powered "XPEDITION" Stair Chair for a total cost not to exceed \$36,391.45, as set forth in the attached quotations and the Chief of Fire and Director of Finance shall be authorized to take all actions required to obtain the reimbursement to the City of \$27,293.59 of this purchase price.

Section 2: The Director of Finance is directed to appropriate funds from Fund No. 233-1300-54500 for the purchase authorized in Section 1 of this Resolution.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


