A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH MARSHALL POWER EQUIPMENT LLC THROUGH THE SOURCEWELL COOPERATIVE PURCHASING PROGRAM FOR THE PURCHASE OF A LEAF BLOWER FOR THE DEPARTMENT OF PUBLIC SERVICE.

WHEREAS, the City has obtained a quote from Marshall Power Equipment LLC to provide a stand-up leaf blower under the competitively bid Sourcewell cooperative purchasing contract for the price of \$12,429.00.

WHEREAS, the Charter of the City of Richmond Heights provides that this Council may authorize purchases from cooperative purchasing programs of political subdivisions, and Sourcewell is a local government unit, corporation and public agency under the laws of the state of Minnesota which awarded a competitively bid contract for this equipment;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Marshall Power Equipment LLC for a stand-up leaf blower as set forth in Invoice Estimate # 2666, a copy of which is attached hereto as Exhibit A, for a total amount not to exceed \$12,429.00;

Section 2: The Director of Finance is authorized to utilize Fund No. 401-7150-54650 to cover the cost of the purchase authorized in Section 1 of this Resolution.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


