A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH MUNICIPAL EMERGENCY SERVICES, INC. FOR THE PURCHASE OF PROTECTIVE GEAR FOR STRUCTURAL FIREFIGHTING FOR THE DIVISION OF FIRE.

WHEREAS, the Chief of Fire has advised that the City requires protective ensembles and related accessories for structural firefighting known as "turn-out gear" for five (5) new firefighters, the purchase of which can be made from a vendor, Municipal Emergency Services, Inc., through the competitively bid Sourcewell cooperative purchasing contract at a total cost not to exceed \$7,461.00, as set forth in the quote attached hereto as "Exhibit A".

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Municipal Emergency Services, Inc., 6880 Tod Avenue SW, Warren, Ohio 44481, for the purchase of protective ensembles and related accessories for structural firefighting known as "turn-out gear," as set forth in the quote attached hereto as "Exhibit A," at a cost not to exceed \$7,461.00.

Section 2: The Director of Finance is authorized to appropriate funds from Fund No. 233-1300-54500 for the cost of the purchase agreement authorized in Section 1 of this Resolution.


