A RESOLUTION AUTHORIZING THE DISPOSITION OF UNNEEDED CITY EQUIPMENT FOR A TRADE-IN ALLOWANCE/STORE CREDIT WITH MARSHALL POWER EQUIPMENT LLC.

WHEREAS, the Director of Public Service has requested to sell certain City equipment that is unneeded, obsolete and/or unfit for the use for which it was acquired for a trade-in allowance/store credit, as set forth in the quote from Marshall Power Equipment LLC attached hereto as Exhibit A, for a total credit of \$1,500 for one used 48-inch walk behind mower and one used 61-inch riding mower;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The following items of personal property are determined not to be needed for public use, and/or are obsolete or unfit for the use for which they were acquired and may be sold to Marshall Power Equipment LLC for a trade-in allowance/store credit in the total amount of \$1,500, as set forth in Exhibit A:

- 1) 48-inch Scag Walk Behind Mower; and
- 2) 61-inch Turf Tiger Scag Mower.




