

RESOLUTION NO.: 100-2024

**A RESOLUTION RE-APPOINTING CITY OF RICHMOND HEIGHTS  
APPOINTEE CITIZEN MEMBER FRED CASH TO THE BOARD OF  
TRUSTEES OF THE BELLE OAKS NEW COMMUNITY AUTHORITY.**

**WHEREAS**, on June 9, 2020, the Council of the City of Richmond Heights (organizational board of commissioners per Ohio Revised Code § 349.01), by the passage of Resolution No. 54-2020, established the Belle Oaks New Community Authority as a body politic and corporate for the purposes described in that Resolution and related to the development of the Belle Oaks Project;

**WHEREAS**, this Council determined, by the passage of Resolution No. 54-2020, that the Board of Trustees shall be comprised of seven (7) members selected and appointed as provided in the Petition for the New Community Authority;

**WHEREAS**, pursuant to the authority to establish a new community authority set forth in Chapter 349 of the Ohio Revised Code, and Resolution No. 54-2020, this Council appointed, by the passage of Resolution No. 58-2020, citizen member Fred Cash, among others, to the Board of Trustees of the New Community Authority, to a two-year term expiring at the end of June 15, 2022;

**WHEREAS**, this Council re-appointed, by the passage of Resolution No. 74-2022, as citizen members Fred Cash to the Board of Trustees of the New Community Authority to an additional two-year term expiring at the end of June 15, 2024;

**WHEREAS**, pursuant to this Council's authority set forth in Chapter 349 of the Ohio Revised Code, this Council desires to re-appoint citizen member Fred Cash to the Board of Trustees of the Belle Oaks New Community Authority to a third two-year term commencing as of June 16, 2024.

**NOW, THEREFORE**, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

**Section 1:** Fred Cash is re-appointed as an appointee of the Council of the City of Richmond Heights to the Board of Trustees of the Belle Oaks New Community Authority as a citizen member for a two-year term commencing as of June 16, 2024, and expiring at 11:59 p.m. on June 15, 2026;


