

RESOLUTION NO.: 125-2024

INTRODUCED BY: Mayor Thomas *and Lewis*

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH VASCO SPORTS CONTRACTORS THOUGH THE OMNIA PARTNERS COOPERATIVE PURCHASING PROGRAM FOR THE BASEBALL/ SOFTBALL FIELDS RENOVATIONS.

WHEREAS, the Charter of the City of Richmond Heights provides that this Council may authorize purchases exceeding twenty-five thousand dollars without public competitive bidding where the City is participating in cooperative purchasing programs of political subdivisions, and OMNIA Partners is a cooperative purchasing organization dedicated to public sector procurement that awarded a competitively bid contract to Vasco Sports Contractors for playing field renovations;

WHEREAS, the City's Director of Recreation has obtained a quote from Vasco Sports Contractors to provide baseball/softball field renovations in the City's Community Park under its OMNIA Partners contract in the amount of \$57,087.00 and has obtained two other quotes from other companies who are not in government cooperative purchasing program contracts that are both higher than this quote of Vasco.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a contract with Vasco Sports Contractors for a baseball/softball fields renovations in the City's Community Park as set forth in the quote dated August 21, 2024, a copy of which is attached hereto as Exhibit A, for a total amount not to exceed \$57,087.00;

Section 2: The Director of Finance is authorized to utilize Capital Improvement Fund #401-7150-52100 to cover the cost of the improvement contract authorized in Section 1.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.




2. Establish proper slope for field to achieve optimal drainage
3. Use laser grader to move existing infield mix accordingly
4. Add 25 TN of Diamond Clay Conditioner to top dress field
5. Finish drag to prepare field for play

Regrade Softball Field Scope of Work

1. Edge infield to achieve desired shape
2. Establish proper slope for field to achieve optimal drainage
3. Use laser grader to move existing infield mix accordingly
4. Add 12 TN of Diamond Clay Conditioner to top dress field
5. Finish drag to prepare field for play

Regrade Baseball Field #2 Scope of Work

1. Edge infield to achieve desired shape
2. Establish proper slope for field to achieve optimal drainage
3. Use laser grader to move existing infield mix accordingly
4. Add 12 TN of Diamond Clay Conditioner to top dress field
5. Finish drag to prepare field for play

Rebuild Heavy Traffic Areas Scope of Work

1. Layout new pitching lane, batter's boxes, and catcher's box accounting for new finished grade
2. Excavate new areas 3 1/2" below finish grade
3. Spread 1" base layer of RediMound clay, tamp down, andamped for adhesion
4. Install RediBricks in Excavated area
5. Backfill around edges with excavated material and tamp down to ensure fit of bricks
6. Use remaining RediMound Mix to fill in cracks and tamp down to compact.
7. Finish with conditioner mix on top
