A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AMENDMENT TO THE AGREEMENT WITH PC ALTERNATIVES, LLC FOR INFORMATION TECHNOLOGY SUPPORT SERVICES FOR THE CITY TO INCREASE THE AMOUNT OF THE AGREEMENT.

WHEREAS, pursuant to Resolution No. 18-2022, passed by this Council on February 22, 2022, the City entered into an agreement with PC Alternatives, LLC of Richmond Heights, Ohio, for information technology support services for a term of one (1) year, from January 1, 2022, through December 31, 2022 (the "Agreement");

WHEREAS, that Agreement was renewed for the period of January 1, 2023, through December 31, 2023, as authorized by Resolution No. 14-2023, passed by this Council on February 14, 2023, and was again renewed for the period of January 1, 2024, through December 31, 2024, as authorized by Resolution No. 38-2024, passed by this Council on March 19, 2024;

WHEREAS, professional continuing information technology support services are necessary for the operation and maintenance of the City's information technology system and facilities, and to continue support services at the level required by the City it will be necessary to increase the amount of the Agreement by \$25,000, thereby increasing the total amount of the Agreement to an amount not to exceed \$45,000;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an amendment of the Agreement with PC Alternatives, LLC approved by this Council and executed in 2022 for information technology support services, and as extended and amended by this Council in 2023 and 2024, to continue through December 31, 2024, in the increased amount of \$25,000, thereby increasing the total amount of the Agreement for 2024 to an amount not to exceed \$45,000 without further authorization from this Council.

Section 2: The funds required for the expense in Section 1 of this Resolution shall come from the General Fund No. 100-7150-52400.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


