

RESOLUTION NO.: 137-2024

A RESOLUTION AUTHORIZING THE MAYOR TO SUBMIT AN APPLICATION FROM THE CITY OF RICHMOND HEIGHTS FOR A PROJECT TO BE CONSIDERED BY THE CUYAHOGA COUNTY DEPARTMENT OF DEVELOPMENT FOR ITS COMMUNITY DEVELOPMENT SUPPLEMENTAL GRANT PROGRAM FOR FISCAL YEAR 2025, AUTHORIZING THE PAYMENT OF MATCHING FUNDS AND/OR IN-KIND SERVICES FROM THE CITY, AND CORRECTING RESOLUTION NO. 133-2024.

WHEREAS, the City has been advised by the Cuyahoga County Department of Development that it is eligible to participate in a competitive application process for awarding of Community Development Supplemental Grant Program funds for Fiscal Year 2025;

WHEREAS, the City is permitted to submit one or more projects as part of its application, provided the aggregate total of the funding does not exceed \$50,000 for the Supplemental Grant Program;

WHEREAS, the grant encourages the City to make a local match to the grant in the form of direct monetary payments and/or in-kind services for the project(s) and it is determined by this Council that a required City match to the grant through a direct monetary payment and/or in-kind services will be made;

WHEREAS, a public hearing related to the City's participation in the Community Development Supplemental Grant Program for Fiscal Year 2025 was held by the City on August 6, 2024;

WHEREAS, pursuant to Resolution No. 133-2024, adopted by this Council on September 10, 2024, the public improvement project identified in that Resolution was incorrect and this Resolution corrects that error;

WHEREAS, the Mayor and this Council wish to continue to apply for the supplemental grant funds for the a necessary public improvement project to remediate an unsafe porch and overhang at the Greenwood Farm Park and to authorize the required local City match consisting of a combination of a monetary payment and in-kind services.

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The following public improvement project for the purpose of improving the public health, safety and welfare and providing a place for the safe recreational enjoyment of the citizens of the City of Richmond Heights is approved for inclusion in the application to be submitted by the City in response to the competitive application process undertaken by the

Department of Development of Cuyahoga County for Community Development Supplemental Grant funds:

Remediation of Porch and Overhang of Home at Greenwood Farm Park.

Section 2: The Mayor is authorized to submit the application for the aforesaid public improvement project, including a commitment to providing the required local City match consisting of a combination of a monetary payment and in-kind services, on behalf of the City to the Department of Development of Cuyahoga County.

Section 3: The Director of Finance is authorized to utilize Capital Improvement Fund No. 401 for the payment of the City's monetary matching funds authorized in Section 2 of this Resolution.

Section 4: Resolution No. 133-2024 of this Council is hereby corrected as set forth in the recitals to this Resolution.


