A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH SHERWIN WILLIAMS FOR THE PURCHASE LINE STRIPING EQUIPMENT FOR THE DEPARTMENT OF PUBLIC SERVICE.

WHEREAS, the Director of Public Service has advised that the City needs a new linelazer and has received a quote from Sherwin Williams to supply a linelazer as set forth in the quote attached hereto as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Sherwin Williams for the purchase of one (1) linelazer, as set forth in the quote attached hereto as Exhibit A, at a cost not to exceed \$7,995.00.

Section 2: The Director of Finance is authorized to appropriate funds from Fund No. 201-6450-53150 for the cost of the purchase agreement authorized in Section 1 of this Resolution.



Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


