A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH MIDDLEFIELD FARM GARDEN FOR THE PURCHASE OF TREE PLANTING EQUIPMENT.

WHEREAS, the Director of Public Service has advised that it is necessary to purchase augers and a motor for planting new trees this fall;

WHEREAS, the City has received a quote from Middlefield Farm Garden to supply the above described equipment for a price of \$6,650.00, as set forth in the quote attached hereto as "Exhibit A".

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with Middlefield Farm Garden for the purchase of augers and a motor, as set forth in the quote attached hereto as "Exhibit A", at a cost not to exceed \$6,650.00.

Section 2: The Director of Finance is authorized to utilize Fund No. 100-6450-52450 to cover the cost of the purchase authorized in Section 1 of this Resolution.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
