**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH TRAVELERS INSURANCE COMPANY FOR CRIME INSURANCE COVERAGE.**

WHEREAS, the City's insurance agent and risk manager under the Northern Ohio Risk Management Association (NORMA), Wichert Insurance as administrator thereof, has procured a proposal from Travelers Insurance Company for a crime coverage insurance policy for a three-year term for an annual premium of \$2,301.00 under the terms set forth in the proposal attached hereto as "Exhibit A";

WHEREAS, this Council desires to authorize the Mayor to enter into an agreement with Travelers Insurance Company for this necessary insurance coverage.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an insurance agreement with Travelers Insurance Company for a crime coverage insurance policy for a three-year term from October 1, 2024 through October 1, 2027, for an annual premium cost of Two Thousand Three Hundred One Dollars (\$2,301.00) as set forth in "Exhibit A".

Section 2: The Director of Finance is authorized to certify that funds have been appropriated from Fund No. 100-7150-52127 for the cost of the agreement authorized in Section 1.


Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


