

RESOLUTION NO.: 147-2024
INTRODUCED BY: Mayor and All of Council

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE ALLEGHENY AIRPORT AUTHORITY FOR AIRPORT RESCUE FIRE FIGHTING (ARFF) TRAINING FOR THE DIVISION OF FIRE AND TO EXPEND FUNDS THEREFOR FROM AN ASSISTANCE TO FIREFIGHTERS GRANT FROM THE U.S. DEPARTMENT OF HOMELAND SECURITY.

WHEREAS, by Resolution No. 95-2023, passed by Council on June 27, 2023, the City accepted a U.S. Department of Homeland Security "Assistance to Firefighters Grant" (the "Grant") in the amount of \$64,316.40 for Airport Rescue Fire Fighting (ARFF) training, travel, and staffing expenses for Division of Fire personnel to attend the training;

WHEREAS, the City has received a proposal from the Allegheny County Airport Authority, a not-for-profit Municipal Authority providing quality, hands-on training for fire and rescue teams, to provide five (5) days of training sessions on ARFF for the City's Division of Fire personnel for the amount of seven thousand eight hundred seventy-five dollars (\$7,875.00);

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with the Allegheny County Airport Authority, Pittsburgh, PA, to provide ARFF Training to the Division of Fire personnel for a total cost not to exceed \$7,875.00, as set forth in Exhibit A hereto.

Section 2: The Director of Finance is authorized to utilize funds from Fund No. 203-1300-52250 for the cost of the purchase agreement authorized in Section 1 of this Resolution.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


