

RESOLUTION NO.: 23-2025

INTRODUCED BY: Mayor Thomas and All of Council

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH MUNICIPAL EMERGENCY SERVICES, INC. FOR THE PURCHASE OF A RACK STORAGE SYSTEM FOR STRUCTURAL FIREFIGHTING EQUIPMENT FOR THE DIVISION OF FIRE.

WHEREAS, the Chief of Fire has advised that the City's Division of Fire requires a rack storage system for structural firefighting equipment known as "turn-out gear", the purchase of which can be made from a vendor, Municipal Emergency Services, Inc., at a total cost not to exceed \$8,948.00, as set forth in the quote attached hereto as "Exhibit A";

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Municipal Emergency Services, Inc., 6880 Tod Avenue SW, Warren, Ohio 44481, for the purchase of a rack storage system for structural firefighting equipment as set forth in the quote attached hereto as "Exhibit A," at a cost not to exceed \$8,948.00.

Section 2: The Director of Finance is authorized to appropriate funds from Fund No. 233-1300-54500 for the cost of the purchase agreement authorized in Section 1 of this Resolution.


