

RESOLUTION NO.: 31-2025

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH BEST TRUCK EQUIPMENT INC. FOR TWO PIECES OF EQUIPMENT UNDER SOURCEWELL COOPERATIVE PURCHASING PROGRAM BID PRICING FOR USE BY THE DEPARTMENT OF PUBLIC SERVICE AND AUTHORIZING THE SIMULTANEOUS TRADE-IN OF A KUBOTA TRACTOR UNNEEDED FOR PUBLIC USE.

WHEREAS, pursuant to the City Charter, this Council may authorize expenditures in excess of twenty-five thousand dollars without public bidding through participation in cooperative purchasing programs such as Sourcewell;

- WHEREAS, this Council finds that based on the information from the City's Director of Public Service and Properties, the City's 2014 Kubota RTV X1100C with approximately 1,600 service hours (VIN # A5KC2GDBAFG021329) is no longer needed for public use;

WHEREAS, the City has received a quote from Best Truck Inc. of Painesville, Ohio for two pieces of motorized equipment as described in Exhibit A, attached hereto, under the Sourcewell Cooperative Purchasing Program bid price of \$73,599.04 (Sourcewell Contract # 122220-PSI) and to receive a trade-in credit of \$1,200 for the 2014 Kubota RTV X1100C, with the net purchase price amount of \$72,399.04, as set forth in the quotes attached hereto as Exhibit A.

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with Best Truck Equipment Inc. for the purchase of two pieces of equipment for the Department of Public Service at the purchase price of \$73,599.04 and to trade in a 2014 Kubota RTV X1100C for a credit of \$1,200.00, all as set forth in the quotes attached hereto as Exhibit A, for a net purchase price amount not to exceed \$72,399.04

Section 2: The following vehicle is determined to be unneeded for public use, and/or is obsolete, or unfit for the use for which it was acquired and may be traded in for credit against the price of the two pieces of equipment set forth in Exhibit A hereto:

2014 Kubota RTV X1100C with approximately service 1,600 service hours (VIN # A5KC2GDBAFG021329).

Section 3: The purchase of the equipment authorized in Section 1 of this Resolution and the cost of the agreement therefor shall come from Fund No. 401-7150-54650.


