A RESOLUTION AUTHORIZING THE MAYOR TO PURCHASE A
BATTERY-POWERED SMOKE EJECTOR FOR THE DIVISION OF FIRE.

WHEREAS, the Chief of Fire has advised that the Division needs a battery-powered electric smoke ejector fan, the purchase of which can be made from a vendor, Atlantic Emergency Solutions, Inc., at a total cost not to exceed \$6,463.49.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Atlantic Emergency Solutions, Inc., 12351 Randolph Ridge Lane, Manassas, VA 20109, for the purchase of one (1) Super Vacuum Manufacturing Co., Inc. Model V20-BL-12-SP variable-speed, battery-powered, smoke ejector fan for the Division of Fire at a cost not to exceed \$6,463.49.

Section 2: The Director of Finance is authorized to appropriate funds from Fund No. 233-1300-54500 for the cost of the purchase agreement authorized in Section 1 of this Resolution.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
