

ORDINANCE NO.: 74-2025
INTRODUCED BY: Mayor Thomas

AN ORDINANCE AMENDING THE ZONE MAP OF THE CITY OF RICHMOND HEIGHTS TO DESIGNATE CERTAIN PROPERTIES TO BE WITHIN THE B-3 GENERAL BUSINESS DISTRICT AND TO DESIGNATE CERTAIN PROPERTIES TO BE WITHIN THE R-1 SINGLE-FAMILY RESIDENTIAL DISTRICT.

WHEREAS, pursuant to Ordinance No. 71-2025, this Council has amended the Zoning Code to include a new commercial business zoning district named the B-3 General Business District and this Council wishes to apply that zoning district designation on several parcels of land in the vicinity of the Cuyahoga County Airport in order to enhance the economic development of that area of the City and for the general welfare of the City, its residents, and the affected property owners;

WHEREAS, several parcels to the north of said Airport that are being used for residential homes were rezoned to the I-1 Office-Industrial District several years ago and this Council and the residents of those parcels desire that the parcels be rezoned to R-1 Single-Family Residential District to further the public health, safety, and general welfare and for the benefit of the affected property owners;

WHEREAS, pursuant to City Charter Article VI, Section 7, this Ordinance was referred to the City's Planning Commission for review and recommendation and the Ordinance, prior to its consideration for passage by this Council, has been recommended to the Council for adoption;

WHEREAS, pursuant to City Charter Article VI, Section 8, a public hearing was held on this Ordinance prior to its consideration for passage by this Council;

NOW, THEREFORE, Be It Ordained by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1. The following Permanent Tax Parcels in the City of Richmond Heights are hereby re-districted from their current Zoning District designation of I-1 Office-Industrial to B-3 General Business District:

Section 3: The City Engineer shall forthwith cause the re-districting of the foregoing parcels of land set forth in Sections 1 and 2 of this Ordinance to be set forth on the official Zone Map of the City of Richmond Heights as provided in Section 1125.03 of Title V - Zoning Code of the Codified Ordinances.




