A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH KALIDA TRUCK EQUIPMENT, INC FOR AN AUGER ASSEMBLY FOR THE DEPARTMENT OF PUBLIC SERVICE.

WHEREAS, the Director of Public Service has advised that it is necessary to purchase an auger assembly for a salt spreader for the Department of Public Service;

WHEREAS, the City has received a quote from Kalida Truck Equipment, Inc. to supply the above-described equipment for a price of \$5,271.00, as set forth in the quote attached hereto as "Exhibit A".

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with Kalida Truck Equipment, Inc. for the purchase of an auger assembly and bearing, as set forth in the quote attached hereto as "Exhibit A", at a cost not to exceed \$5,271.00.

Section 2: The Director of Finance is authorized to utilize Fund No. 201-6450-53300 to cover the cost of the purchase authorized in Section 1 of this Resolution.


