

RESOLUTION NO.: 158-2025

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH ROLLNRACK, LLC FOR THE PURCHASE OF A POWERED FIRE HOSE ROLLING SYSTEM FOR THE DIVISION OF FIRE AND UTILIZING U.S. DEPARTMENT OF HOMELAND SECURITY GRANT FUNDS.

WHEREAS, the Division of Fire has requested, and the Council's Safety Committee has recommended the purchase of a powered fire hose rolling system, the purchase of which can be made from a vendor, RollNRack, LLC, at a total cost not to exceed \$7,420.00, as set forth in the quote attached hereto as "Exhibit A";

WHEREAS, the City has received an "Assistance to Firefighters Grant" from the U.S. Department of Homeland Security in the total amount of \$51,100.00, which includes a requirement of five percent (5%) matching funds by the City in the amount of \$2,433.34, for the purchase of fire hose, appliances, and testing equipment, a portion of which will be utilized for this purchase.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with RollNRack, LLC, P.O. Box 328, Mukwonago, Wisconsin 53149, for the purchase of one (1) Power Roller with 5 inch Storz Coupling Jaws for the management of fire hose as set forth in the quote attached hereto as "Exhibit A," at a cost not to exceed \$7,420.00.

Section 2: The Director of Finance is authorized to appropriate funds from Fund No. 233-1300-54500 for the cost of the purchase agreement authorized in Section 1 of this Resolution.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


