

RESOLUTION NO.: 6-2026
INTRODUCED BY: Mayor Thomas

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH LIBERTY FORD FOR THE PURCHASE OF TWO (2) 2026 FORD F-150 PICKUP TRUCKS, THREE (3) 2026 FORD INTERCEPTOR SPORT UTILITY VEHICLES, AND ONE (1) 2026 FORD MAVERICK PICKUP TRUCK FOR A PRICE BELOW THE OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES COOPERATIVE PURCHASING PROGRAM BID PRICING FOR USE BY THE DEPARTMENT OF PUBLIC SERVICE, THE DIVISIONS OF FIRE AND POLICE, AND THE DEPARTMENT OF RECREATION, AND AUTHORIZING THE SIMULTANEOUS TRADE-IN OF CITY VEHICLES UNNEEDED FOR PUBLIC USE.

WHEREAS, pursuant to the City Charter, this Council may authorize expenditures in excess of twenty-five thousand dollars without public advertising through participation in the cooperative purchasing programs of political subdivisions, including the State of Ohio Department of Administrative Services' Cooperative Purchase Program, and under state law, political subdivisions may purchase from vendors other than those contracting with cooperative purchasing programs, upon equivalent terms, conditions, and specifications, but at a lower price than the pricing available under such programs;

WHEREAS, the City has received quotes from Liberty Ford, Inc., 5500 Warrensville Center Road, Maple Heights, Ohio 44137, for two (2) 2026 Ford F-150 pickup trucks, three (3) 2026 Ford Interceptor Sport Utility Vehicles, and one (1) 2026 Ford Maverick Pickup Truck at pricing lower than the pricing available under the State Cooperative Purchasing Program bid price, as set forth in the quotes attached hereto as "Exhibits 1, 2, 3, 4, 5, and 6."

WHEREAS, Ohio Revised Code §721.15 authorizes this Council to adopt a resolution to authorize the sale of obsolete, unneeded, or unfit vehicles, equipment, or machinery simultaneously with the purchase of the new vehicles, equipment, or machinery of similar type and to have the selling price credited against the purchase price of other vehicles, equipment, or machinery;

WHEREAS, this Council finds that based on the information from the City's Director of Public Service and Properties, the following vehicles are determined to be unneeded for public use, and/or obsolete or unfit for the use for which they were acquired, and may be traded in for credit against the price of one (1) 2026 Ford F-150 pickup truck, and three (3) 2026 Ford Police Interceptors, from Liberty Ford Inc. (See Exhibits 1, 2, 3, and 4).

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with Liberty Ford for the purchase of two (2) 2026 Ford F-150 pickup trucks, three (3) 2026 Ford Interceptor Sport Utility Vehicles, and one (1) Ford Maverick Pickup Truck, as set forth in the quotes attached hereto as "Exhibits 1, 2, 3, 4, 5, and 6", at a total cost not to exceed \$266,955.00, including the aforementioned trade-in credits for the vehicles determined to be unneeded for public use.

Section 2: The purchase of the vehicles authorized in Section 1 of this Resolution and the cost of the purchase agreement therefor is contingent upon the appropriation of Council for that amount and the placement of funds into Fund No. 401-7150-54650 and Fund No. 233-1300-54650.


Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
