

RESOLUTION NO.: 82 -2007

A RESOLUTION EXTENDING A SOLID WASTE COLLECTION AND DISPOSAL CONTRACT WITH REPUBLIC WASTE SERVICES OF OHIO HAULING, LLC THROUGH SEPTEMBER 16, 2007; AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to Resolution No. 62-2007 of this Council, the City of Richmond Heights extended a contract with Republic Waste Services of Ohio Hauling, LLC ("Republic") to perform solid waste collection and disposal services for the City of Richmond Heights for a term through August 31, 2007 (hereinafter the "Contract"); and

WHEREAS, it is necessary to further extend the aforesaid Contract from September 1, 2007 through September 16, 2007 in order to continue to maintain solid waste collection and disposal services in furtherance of the public health, safety and welfare of the residents of the City and in order to have the additional time needed to complete the public bid process for a new contract for said services going forward;

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The term of the Contract set forth in the preamble to this Resolution shall be extended from September 1, 2007 through September 16, 2007 under the existing terms of said Contract, except that the compensation to be paid to Republic under the extended Contract shall be a combined price for both collection and disposal of solid waste of \$9.57 per month per household. A written agreement memorializing the extension of the term and the aforesaid rate of compensation shall be executed by the parties.

Section 2: The Mayor of the City is hereby authorized and directed to execute the extension agreement referred to in Section 1 of this Resolution on behalf of the City and the Director of Finance is authorized and directed to appropriate to a proper account the sums sufficient to cover the cost of said agreement.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution is hereby declared to be an emergency measure immediately necessary to preserve the public health, safety and general welfare of the citizens of the City and for the further reason that this Resolution is required to be immediately effective to provide solid waste collection and disposal services which is to eliminate existing and potential hazards to the health, safety and welfare the residents and visitors of the City; wherefore this Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
