**A RESOLUTION ACCEPTING THE BIDS FOR THE VARIOUS
SECTIONS OF THE BID SPECIFICATIONS FOR REPAIRS AND
RESURFACING OF VARIOUS CITY STREETS FOR THE 2008
ROAD PROGRAM AND AUTHORIZING CONTRACTS
THEREFOR.**

Whereas, pursuant to legal notice therefor, duly published according to law, sealed bids were received at the office of the Clerk of Council of the City of Richmond Heights for labor and materials for repairs and resurfacing of various City streets for the City's 2008 Road Program in accordance with specifications prepared by the City Engineer and on file in the office of the Clerk of Council; and

Whereas, pursuant thereto, the lowest and best bids received for said labor and materials for the various Sections of the Road Program bid specifications were:

SECTIONS I, IA, II and IIA: MGL Enterprises, Inc. \$498,586.40

SECTIONS III, IIIA, IV and IVA:

Specialized Construction, Inc. 41,994.60

TOTAL \$540,580.80

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The following bids in the total amount of \$540,580.80 for Sections I, IA, II, IIA, III, IIIA, IV and IVA of the City's bid specifications for labor and materials for resurfacing and repairs of various City streets for the 2008 City Road Program, being the lowest and best bids received for such labor and materials be, and the same are hereby, accepted and approved; and the Mayor and Finance Director of the City be, and they are hereby, authorized and directed to execute and enter into on behalf of the City proper contracts for said labor and materials in accordance with the specifications prepared by the City Engineer as follows:

SECTIONS I, IA, II and IIA: MGL Enterprises, Inc. \$498,586.40

SECTIONS III, IIIA, IV and IVA:

Specialized Construction, Inc. \$ 41,994.60

Section 2: The Finance Director is authorized and directed to appropriate to a proper account a sum sufficient to cover the cost of said contracts.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
